Magmatic Effects hereby warrants, to the original purchaser, Magmatic products to be free of manufacturing defects in material and workmanship for a period of two years (730 days) from the original date of purchase. This warranty excludes discharge lamps and all product accessories. This warranty shall be valid only if the product is purchased within the United States of America, including possessions and territories. It is the owner's responsibility to establish the date and place of purchase by acceptable evidence, at the time service is sought.

B. For warranty service, send the product only to the Magmatic Effects factory. All shipping charges must be pre-paid. If the requested repairs or service (including parts replacement) are within the terms of this warranty. Magmatic Effects will pay return shipping charges only to a designated point within the United States. If any product is sent, it must be shipped in its original package and packaging material. No accessories should be shipped with the product. If any accessories are shipped with the product, Magmatic Effects shall have no liability what so ever for loss and/or or damage to any such accessories, nor for the safe return thereof.

C. This warranty is void if the product serial number and/or labels are altered or removed; if the product is modified in any manner which Magmatic Effects concludes, after inspection, affects the reliability of the product; if the product has been repaired or serviced by anyone other than the Magmatic Effects factory unless prior written authorization was issued to purchaser by Magmatic Effects; if the product is damaged because not properly maintained as set forth in the product instructions, guidelines and/or user manual.

#### LIMITED WARRANTY (USA ONLY)

### WARRANTY RETURNS (USA ONLY)

To obtain warranty service, a Return Material Authorization (RMA) number must first be obtained from MAGMATIC. It is the Customer's responsibility to provide product proof of purchase and serial number by acceptable evidence such as an invoice copy or an approved MAGMATIC Extended Warranty Certificate ("EWC") and any relevant maintenance records at the time warranty service is sought. Failure to provide acceptable evidence of product proof of purchase or EWC and any relevant maintenance records may be cause for denial of warranty service.

Products returned for warranty service must be sent without any accessories (i.e., power, data, and safety cables, brackets, clamps, rigging hardware, frost filters, gel frames, barn doors, lenses, hoses, nozzles, rack mounting hardware, etc.), must be boxed using the original and/or suitable packaging materials (double-box and foam) that provides ample product protection for ground and/or air freight transit, and must be shipped freight pre-paid and insured to MAGMATIC in Los Angeles, CA or a MAGMATIC Authorized Service Center. The RMA number must be clearly written on the outside of the return box, and a brief description of the problem and the RMA number must be documented and included in the box.

### WARRANTY RETURNS (USA ONLY)


Products returned for warranty service without an RMA number clearly marked on the outside of the package will be refused and returned to the shipper at the Customer's expense. Products returned for warranty service, which are received damaged due to inadequate and/or improper packaging and/or due to damage caused by the shipping carrier, may inccur additional repair charges before warranty service begins and/or may void this warranty. If any product accessories (included and/or optional) are shipped with the product, MAGMATIC and/or the MAGMATIC Authorized Service Center shall have no liability what so ever for the loss and/or damage warranty repairs or service (including parts replacement) are within the terms of this warranty, MAGMATIC will pay return ground transportation shipping charges to a single designated point within the United States.

### SAFETY GUIDELINES

#### OVERVIEW TRANSMITTER



 Locate the card input slots on your Magmatic device. Use a screwdriver to remove the slot cover for one of the input slots, then insert the MagRF module and fasten it in place with the module's mounting screws.



Check the display screen on your Magmatic device. The Bluetooth icon and the letters "RF" should appear at the top of the screen, as shown below.



- 3. Select the Personality icon on your Magmatic device's touch screen, then select the "RF Learn" option. Press any of the four keys on the transmitter to pair the transmitter. If pairing is successful, a notification reading "Complete" will appear. On the other hand, if no action is taken within 20 seconds, or if pairing is unsuccessful, a prompt reading "Failed, Try Again" will appear.
- 4. After the receiver and transmitter are paired, the transmitter can be used to control the operation of the device. The assigned functions of each of the four keys on the transmitter vary with the particular device model. See your device's user manual for information.
